**RE: Notice of Establishment of Assessment Monitoring Program
Pursuant to 40 CFR § 257.94(e)(3) and 40 CFR § 257.105(h)(5)**

Cooperative Energy owns and operates R. D. Morrow, Sr. Generating Station (Plant Morrow) located near Purvis, Mississippi. Plant Morrow is subject to the Coal Combustion Residuals (CCR) Rule, 40 CFR Part 257, which establishes a comprehensive set of requirements for the management and disposal of CCR in landfills and surface impoundments by electric utilities.

Section 257.94(e)(3) requires that:

The owner or operator of a CCR unit must prepare a notification stating that an assessment monitoring program has been established. The owner or operator has completed the notification when the notification is placed in the facility's operating record as required by § 257.105(h)(5).

Pursuant to 40 CFR § 257.94(e)(3) and 40 CFR § 257.105(h)(5), Cooperative Energy provides this Notification that it has established an assessment monitoring program as of April 16, 2018 for the Plant Morrow landfill, which is a regulated CCR unit. This Notification has been timely placed in the facility operating record.
