## Quick Facts

- Cooperative Energy employs more than 450 people across the state of Mississippi.
- Cooperative Energy has a combined generating capacity of 1,889 MW\*, representing a diverse generating mix of natural gas, coal, nuclear, hydro and solar.

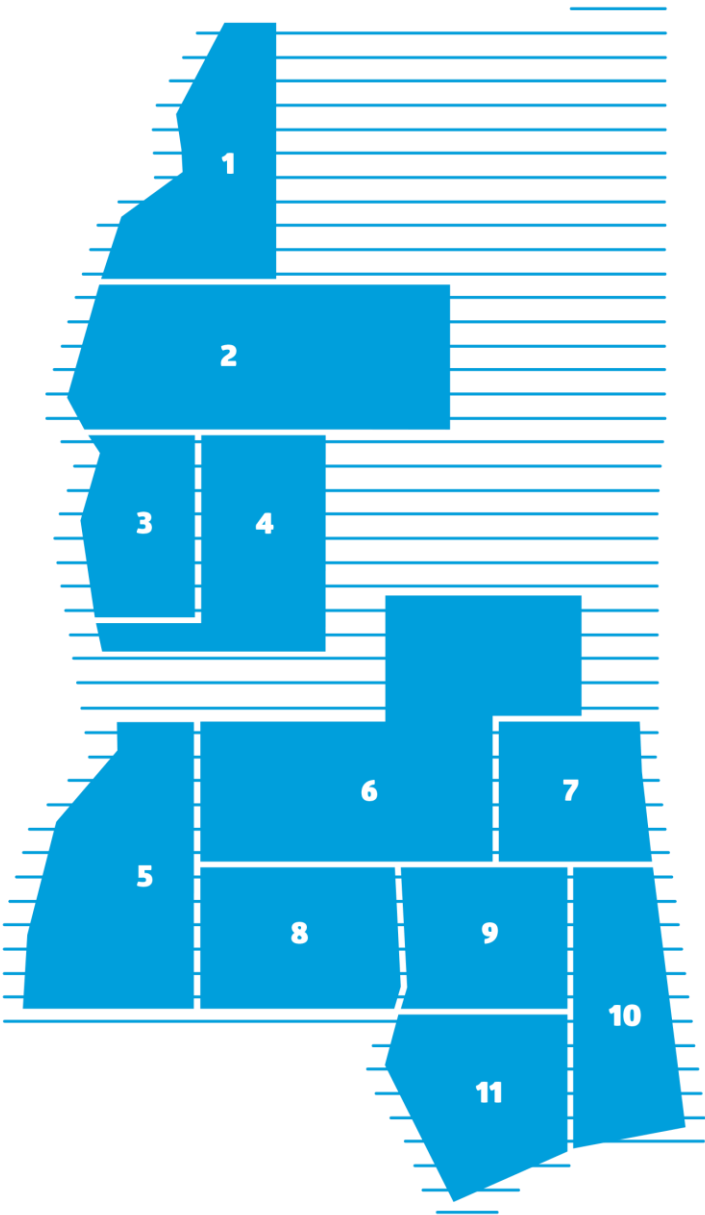
