# **Forest Products**

Forest resources are a major component of Mississippi's economic base covering more than **19.7 million** forested acres, or **62%** of the state's total land area. Of the forested acres, **77%** are privately owned. Mississippi has the natural resources, logistics infrastructure, and specialized workforce to help forest products companies succeed in an increasingly competitive market.



**Did you know?** Forestry is the **#3** agriculture commodity in Mississippi.

The forest products industry in Mississippi is made up of **four** major sectors:

- **Solid Wood Products** pine and hardwood lumber, plywood, poles, oriented strand board, and other composite forest products
- **2. Pulp and Paper** fine writing papers, liner-board used for cardboard boxes, tissues and absorbent papers, and market pulp
- 3. Wood furniture and related products
- 4. Timber harvesting




#### **TAYLORSVILLE INDUSTRIAL SITE**
