# Grants



## Tier 1

Up to **\$10,000** for marketing and community development

Match: None required

- Strategic planning
- Website design
- Retail Recruitment
- Targeted marketing materials, including videos
- Workforce development initiatives
- Industrial property signage and/or aesthetic improvements



## Tier 2

Up to **\$25,000** for marketing and community development

Match: A match of 10% required

- Site visit preparation
- Architectural fees
- Environmental due diligence studies
- On-site demolition
- Fees for consultants or agents necessary to complete site diligence (engineer, attorney, etc.)
- Mississippi Site Development Grant Program matching funds



## Tier 3

Up to **\$50,000** for site preparation.

Match: A match of 20% required

- Site clearing, grubbing, grading
- Transportation infrastructure directly effecting site
- Existing industrial building improvements
- Environmental mitigation or purchase of mitigation credits
- Mississippi Site Development Grant Program matching funds
